3. How do I find the Machine ID for each PC?

A Machine ID is required on your order form for each PC. This ID is necessary to create a licence file for SpeedSheets. To find the Machine ID, follow these steps:

1. Install the trial product on the required computers.
2. Load up Excel and click the first button on the SpeedSheets toolbar (the SpeedSheets logo) to display the menu. See (1) SpeedSheets Menu button below.
3. The SpeedSheets menu will appear.
4. Click the "Licencing" button. This is (2) on the screen display below.
5. Once you have clicked on the Licence button, the Licence SpeedSheets dialog box appears as displayed on the right below.
6. The Machine ID is displayed on this screen as indicated by (3) below.

Record the Machine ID and include this information on your order form. The above procedure will need to be repeated for each PC you want to licence with SpeedSheets.
